

Our first briefing will address the state of civic education in the United States. You must consider not only what the definition of "civic education" is, but also navigate the politicized nature of education to determine what and how Americans should learn about our country.

Our second briefing addresses labor rights and barriers to organizing. In the past few years, several high profile corporations (Starbucks, Amazon, Trader Joe's, Apple, REI, etc.) have come under fire for questionable labor practices. In committee, we will discuss union busting, the right to organize, and how recent events have shed light on potential gaps in worker protection.
