We are living in a time of intense scrutiny towards the courts: questions of partisanship on the bench, legitimacy of decisions, and the future of previously recognized rights circulate in the media and personal discussions. Yet at the same time, disenfranchised populations continue to look to the Supreme Court from oppression, just as they have in the past. Many of the rights we take for granted have their roots in litigation argued before the Supreme Court. As such, this court's justices have historically wielded immense power, and the jurists that argue before them shoulder a tremendous responsibility. In this committee, we hope to allow you to answer some of the questions that have confronted, will confront, or could confront the court through simulating its functioning and handling of constitutional issues.

To prepare for your work on the Supreme Court, you should read each case thoroughly and devise arguments supporting all sides. You should outline the important constitutional questions and anticipate your opposition's arguments. At the conference, you'll be making these arguments to your peers and us—and you'll also be answering questions from the Justices as you argue, just like the real Supreme Court.

HMC is also an excellent opportunity to meet new people and challenge yourself. The Supreme Court is our favorite committee, and we're looking forward to engaging with you on so many intriguing and pressing issues.
